<u>Department of Health and Hospitals Drinking Water Revolving Loan Fund Program</u> - Consideration of Application Number 03-0011 for a Resolution authorizing the development of a program for the Department of Health and Hospitals to provide a tax exempt and/or taxable funding process for non-governmental drinking water projects approved by the Department of Health and Hospitals for loans from the Drinking Water Revolving Loan Fund, and providing for other matters in connection therewith.
